Key Achievements of the National Centre for Human Rights for the Year 2023

The Centre crowned its achievements by retaining “A” status accreditation for the third consecutive time from the Sub-Committee on Accreditation of the Global Alliance of National Human Rights Institutions; and by the election of the Chairperson of the Board of Trustees of the National Centre as a member of the Governance Committee of the Asia Pacific Forum (APF).

This report on the achievements of the National Centre for Human Rights for the year 2023 sets out the tasks discharged by the Centre’s commissions and directorates — monitoring, legislative, training and participatory alike — for the protection and promotion of human rights, pursuant to the powers vested in the Centre by virtue of the National Centre for Human Rights Act No. (51) of 2006 and its amendments, during the year 2023. These tasks and activities constituted the principal source and the cornerstone upon which the substance and the recommendations of the Nineteenth Annual Report were built.

Achievements of the Protection Commission for the Year 2023

The Protection Commission comprises four directorates, namely: the Directorate of Civil and Political Rights; the Directorate of Economic, Social and Cultural Rights; the Directorate of Groups Most in Need of Protection; and the Directorate of International Mechanisms and Report Preparation.

First: Directorate of Civil and Political Rights

The Directorate comprises three units: the Complaints, Follow-up and Cessation of Violations Unit; the Criminal Justice Unit; and the Fundamental Rights and Freedoms Unit.

Complaints, Follow-up and Cessation of Violations Unit: The Unit received (576) complaints during the period extending from November to January of the year 2023; (170) legal opinions were submitted concerning the complaints received, and (883) communications were addressed to the entities concerned.

Criminal Justice Unit: The Unit carried out a series of unannounced field visits to temporary detention centres, amounting to (43) visits, together with one visit to the detention centre of the General Intelligence Department. As regards visits to correction and rehabilitation centres, the Unit carried out (100) visits, including (4) visits to hospital custody wards.

Fundamental Rights and Freedoms Unit

1. Monitoring the supplementary municipal elections in Jerash Governorate (the Bab Amman municipality elections).
2. Monitoring the elections of the Administrative Board of the Union of Charitable Societies – Zarqa Governorate Branch.
3. Carrying out (80) monitoring missions and (9) fact-finding missions.

Second: Directorate of Economic, Social and Cultural Rights

The Directorate comprises two units: the Right to Education Unit, and the Right to Health, Food and Environment Unit.

Key achievements of the Directorate during the year 2022 [as stated in the source]:

1. Conducting a field visit to the Bab Al-Salam factory in Sahab Industrial City.
2. Monitoring and following up the strike of the workers of the Iron and Steel Company.
3. Monitoring and following up the sit-in of the pensioners of the Jordan Phosphate Mines Company, calling for the withdrawal of health insurance from the current insurance company and its return under the umbrella of the Phosphate Company.

4. Monitoring and following up the march of the independent trade unions calling for freedom of trade union organisation and for the amendment of the Labour Act in conformity with international conventions.

Third: Directorate of Groups Most Vulnerable to Violation

The Directorate comprises two units: the Women's Rights Unit, and the Unit for Persons with Disabilities, Older Persons, Juveniles and Children.

1. Preparing the Sixth Shadow Report on the national report under the Convention on the Rights of the Child.
2. Preparing a specialised report on monitoring the reality of the rights of persons with disabilities in benefiting from banks and banking services.
3. Monitoring the conditions of the rights of women, persons with disabilities and older persons in the industrial sector, through field visits to the Union of Workers in the Spinning and Weaving Industry in the Sahab and Dhulail areas and the Dhulail Labour Office; the Tafilah Centre for the Care and Rehabilitation of Persons with Disabilities; the shelter and rehabilitation home for women "Amneh"; the education and rehabilitation home for girls in Zarqa; and the Family Reconciliation Home in Aqaba and Irbid Governorates.
4. Monitoring the conditions of children with disabilities and orphaned children in numerous institutions, including: the Model School for Special Education; King Hussein Orphanage in Irbid Governorate; and King Abdullah II Orphanage in Salt.
5. Monitoring the child's right to play by visiting eight public parks (Housing Bank Park, Ta'reeb Al-Jaysh, Zahran, Salah Al-Din, Prince Hashem Bird Park, Journalists' Park, Shafa Badran, Al-Manhal School Park, and Aya Aghabi Park).
6. Monitoring the conditions of older persons in: Al-Zahraa Home for Older Persons; Al-Amal Centre for Older Persons; and Bayt Al-Ziyara for Older Women.
7. Monitoring the right of women to access justice at the Amman Shari'a Court, and monitoring the right of women to access justice at the Ghor Al-Safi Shari'a Court.
8. Monitoring the conditions of women workers in the agricultural sector through two visits to two farms in the Karameh area of the Middle Jordan Valley.
9. Holding a round table concerning the shadow report on the Convention on the Rights of the Child.
10. Holding two seminars on the occasion of International Women's Day at the University of Jordan and Al al-Bayt University.
11. Holding an awareness session entitled "The Protection of Women from Violence: A Legal Perspective" for the beneficiaries of the shelter and rehabilitation home for women at risk, "Amneh".

Achievements of the Promotion Commission for the Year 2022 [as stated in the source]

The Promotion Commission comprises three directorates, namely: the Directorate of Awareness-Raising and Training; the Directorate of Studies and Documentation; and the Directorate of Legislation; in addition to the Projects Unit.

First: Directorate of Awareness-Raising and Training

1. Delivering (13) lectures on human rights for officers and personnel of the Public Security Directorate; (8) lectures and workshops on numerous human rights subjects for school pupils; and (10) lectures for university students and civil society organisations.
2. Organising (4) training courses targeting official institutions and the students of the Judicial Institute.

3. Holding two seminars: the first on fair trials and human rights, and the second on the Universal Declaration and double standards in the application of international norms.

Second: Directorate of Studies and Documentation

1. Reviewing and editing the Annual Report for the years 2022 and 2023.
2. Preparing a matrix addressing the recommendations of the National Centre for Human Rights and the recommendations of the Universal Periodic Review.
3. Preparing a report on the extent of enforcement of the Centre's recommendations during 2012–2020.
4. Preparing a design for a study on the level of societal awareness of human rights.
5. Strengthening the mechanism of cooperation between the National Centre for Human Rights and the Ministry of Education (updating the memorandum of understanding between the two parties) for the purpose of preparing a study on the level of awareness of human rights among pupils and teachers.
6. Submitting a working mechanism for the activation of the Quadripartite Human Rights Forum.
7. Submitting a legal opinion on the Associations Act.
8. Submitting a legal opinion on the Political Parties Act.

Third: Directorate of Legislation

Preparing a number of legal opinions (the position of the Centre) concerning:

1. The draft Social Security Act.
2. The extradition agreement between the Hashemite Kingdom of Jordan and Romania, and between the Kingdom and the Republic of Cyprus.
3. The Guarantee of the Right of Access to Information Act No. (47) of 2007.
4. The notification to the administrative governor of the activities intended to be carried out by the National Centre, in accordance with the provisions of the National Centre for Human Rights Act and the Public Assemblies Act.
